1. The applications should be as per the prescribed format.
2. Candidates will forward application properly sealed in an envelope through ordinary post duly subscribing the words **“Application for the post of _____”** on the top of envelope while sending the application form.
3. Separate application is required for each post.
4. The crucial date for determining the age limit shall be the closing date for receipt of application.
5. Relaxation of age is admissible as per Govt. of India Rules.

6. Selection shall be by competitive written test. Skill test will be only qualifying.
7. No TA/DA will be admissible for Competitive written test. Candidates will make their own arrangements for boarding and lodging for their appearance in Competitive written test.
8. Selection will be subject to Medical Fitness and verification of character and antecedents from civil authorities.
9. Candidates after selection will be subject to All India service liability.
10. Date, Time and place of test will be intimated by post separately to the eligible candidates whose application is found in order.
11. Candidates will forward self-attested copies of certificates in support of age, educational qualification, experience and caste/community certificate for SC/ST candidates and OBC caste certificate indicating non-creamy layer status for OBC candidates.
12. Department will not be responsible for any postal delay/wrong delivery.
13. Incomplete/incorrect/without signature applications will be rejected without any notice.
14. The recruitment process can be cancelled/suspended/terminated without assigning any reasons. The decision of the Director will be final and no appeal will be entertained.
15. Canvassing in any form shall disqualify the candidate. No enquiry or correspondence will be entertained.
16. Applications from employees working in Central/State Govt. Departments / Public Sector Undertakings and Govt. funded research agencies must be forwarded through proper channel. Advance copies of application will be considered subject to the conditions that the original application through proper channel should reach us before the due date. Application received after the closing date will not be considered.
17. While applying for the above post, the applicant must ensure that he/she fulfills the eligibility and other terms and conditions mentioned as on the specified dates and the particulars furnished are correct in all respects. In case it is detected at any stage of recruitment/selection that the candidate does not fulfill the eligibility norms and/or that he/she has furnished any incorrect / false information or has suppressed any material fact (s), his/her candidature will automatically stand cancelled. If any of the above shortcoming (s) is/are detected even after appointment, his/her services are liable to be terminated without any notice. The decision of the Director, NIRT will be final in this regard.

19. Merely satisfying the essential required minimum qualification and experience does not entitle an applicant to be called for test/appointment.
20. Since it is not possible to call all the eligible candidates for the test, the applicants may be short-listed for this purpose. The decision of the Director, NIRT will be final in this regard.
21. The number of vacancies mentioned is only tentative and may increase/decrease. No enquiry in this regard will be entertained.
