- 3. The crucial date for determining the age limit shall be the closing date for receipt of application.
- **4.** Department will not be responsible for any postal delay/wrong delivery. Incomplete/incorrect/without signature applications will be rejected without any notice.
- **5.** Applications from employees working in Central/State Govt. Departments / Public Sector Undertakings and Govt. funded research agencies must be forwarded through proper channel. Advance copies of application will be considered subject to the conditions that the original application through proper channel should reach us before the due date. Application received after the closing date will not be considered.
- **6.** While applying for the above post, the applicant must ensure that he/she fulfills the eligibility and other terms and conditions mentioned as on the specified dates and the particulars furnished are correct in all respects.
